One Item/Dessert Vendor Contract

REQUIREMENTS/TERMS:

Temporary Food Vendor Permit

For applicable non-mobile vendors, Mecklenburg County Health Department Temporary Food Service Establishment Permit must be completed and filed along with BeachFest Food Vendor Contract. TFE Permit application can be downloaded by visiting www.meckhealth.org then click on a) Environmental Health, b)Forms & Applications, c)Temporary Food Service Establishment Application OR Pushcart/Mobile Food Unit Application. Questions regarding completion of the application should be directed to an Environmental Health Department Sanitarian at 704-336-5100 in Charlotte, NC.

Mobile food trucks/trailers (not submitting a TFE) must submit a copy of their most recent inspection from the Meck County Health Department, along with a statement implying that they will return to their commissary after each day's operation, prior to serving the next day. Friday night's load-out must take place when streets are cleared. Saturday morning move-in must be complete by 9:00am.

Insurance

Food vendors must have in force, a minimum of \$500,000 personal injury and general comprehensive liability coverage (minimum limits of \$500,000 combined single limit coverage for both bodily and property coverage). General comprehensive liability must include Products and Completed Operations coverage and Contractual Liability coverage. Certificate of Insurance must include: Carrier's name, address, phone number with agent's signature, company providing coverage, insured name, address, type of insurance and policy number, effective dates and limit amounts. Provide certificate of insurance to BeachFest Food Vendor Coordinator.

"The Town of Matthews" should be listed as an "Additional Insured" with the mailing address: 232 Matthews Station St. Matthews NC 28105.

Vending Unit Information

- Length measurements must include ALL space required including trailer tongues, storage, hitches, bumpers, generators, etc. Food vendors at BeachFest are positioned along the curb on Trade Street, such that service must occur from the right side of food trucks, or from the fronts of other structures. Maximum 10-feet of depth/width into street permitted. Please be accurate in making your measurements.
- No equipment, materials, supplies, storage, vehicles, trailers, etc. are allowed on sidewalks behind Vendor Unit.
- Save your generators and fuel! We can provide electrical hookup for you, if your connections are compatible with our lines and connections (see attached graphic).



- March 31 Event meets with Health Dept and receives approval/event release from Health Dept;
Any cancellations 3/31-4/15 receive maximum \$85 refund
- April 15 Fee balance of \$175 due
- April 15 *Any cancellations become non-refundable on this date*
- April 18 Festival maps and general information sent to all vendors and participants
- May 13-14 BeachFest Matthews 2016!
